THE CHURCH OF ENGLAND

The future of historic places of worship is one of the most pressing issues facing the historic environment in the early 21st century. The Church of England is responsible for more listed churches than any other denomination. Many have lain at the heart of communities for centuries, but falling congregations and rising maintenance costs place this unique heritage at risk.

The Church of England has placed finding ways of extending the use of churches for the benefit of the whole community at the heart of its national policy on church buildings. There are many administrative and legal arrangements by which churches can be permanently or temporarily shared with a wide variety of secular organisations. This course will examine the strengths and weaknesses of those mechanisms from the perspective of the Church of England, the clergy and local communities, and those with whom buildings are shared. There will be a particular focus on the newest method of sharing space, leasing, made possible by the Pastoral Amendment Measure (2006).

The course will include speakers from the Church of England, English Heritage, the clergy, and community organisations. A particular feature of the seminar is that there will be ample time for questions, discussion and debate.
